Product Usage Instructions

1. Getting Started

To turn on Apple Watch, press and hold the power button.

2. Charging

To charge Apple Watch, use the provided magnetic charger. Simply attach the charger to the back of the watch, and ensure it is properly aligned. Connect the charger to a power source.

3. Safety and Handling

Please refer to the Safety and Handling section in the Apple Watch User Guide for detailed information on how to handle and use Apple Watch safely. Note that Apple Watch, its operating systems, and the health sensors are not medical devices.

4. Exposure to Radio Frequency

To obtain radio frequency exposure information for Apple Watch, open the Apple Watch app on your iPhone. Tap "My Watch," then go to "General," "About," "Legal," and finally "RF Exposure." Alternatively, you can visit apple.com/legal/rfexposure for more information.

5. Battery and Charging

The lithium-ion battery in Apple Watch should only be serviced or recycled by Apple or an authorized service provider. If you need battery service, you may receive a replacement Apple Watch. Remember to recycle or dispose of batteries separately from household waste. For more information about battery service and recycling, visit apple.com/batteries/service-and-recycling. Additionally, refer to the Important Safety Information section in the Apple Watch User Guide for information about charging.

6. Medical Device Interference

Apple Watch, certain bands, and Apple Watch magnetic charging accessories contain magnets that may interfere with medical devices. It is important to review the Important Safety Information section in the Apple Watch User Guide for further details.

7. Avoid Hearing Damage

To prevent possible hearing damage, avoid listening to Apple Watch at high volume levels for extended periods. For more information about sound and hearing, visit apple.com/sound. Detailed guidelines can also be found in the Important Safety Information section of the Apple Watch User Guide.

8. Regulatory


