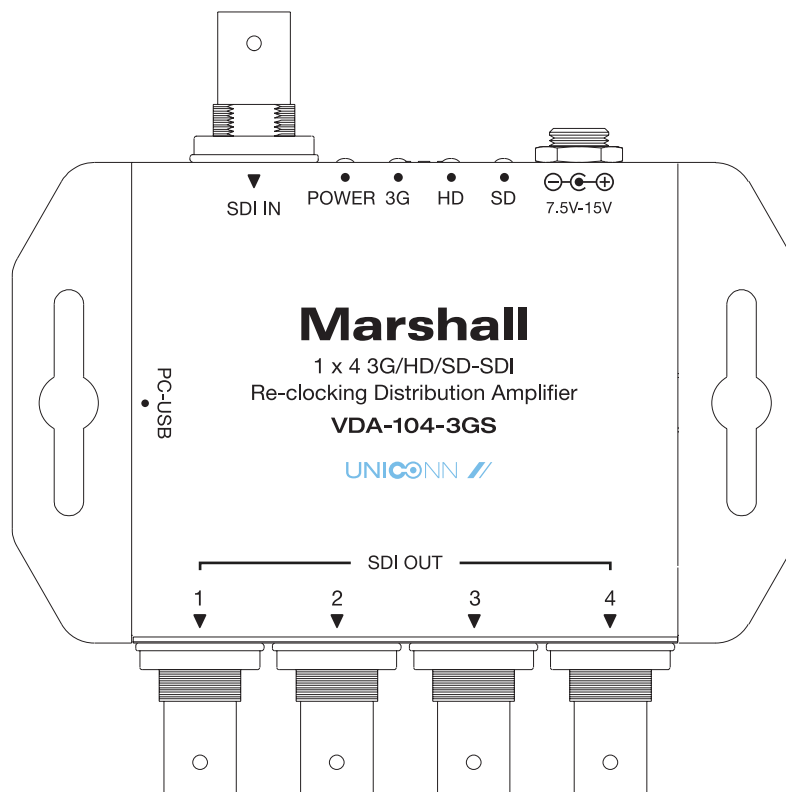

INTRODUCTION

The VDA-104-3GS provides reclocking distribution of an SDI video input signal to four SDI outputs. The input type, whether SDI, HD SDI or 3G SDI is auto detected and displayed via LED indicators.

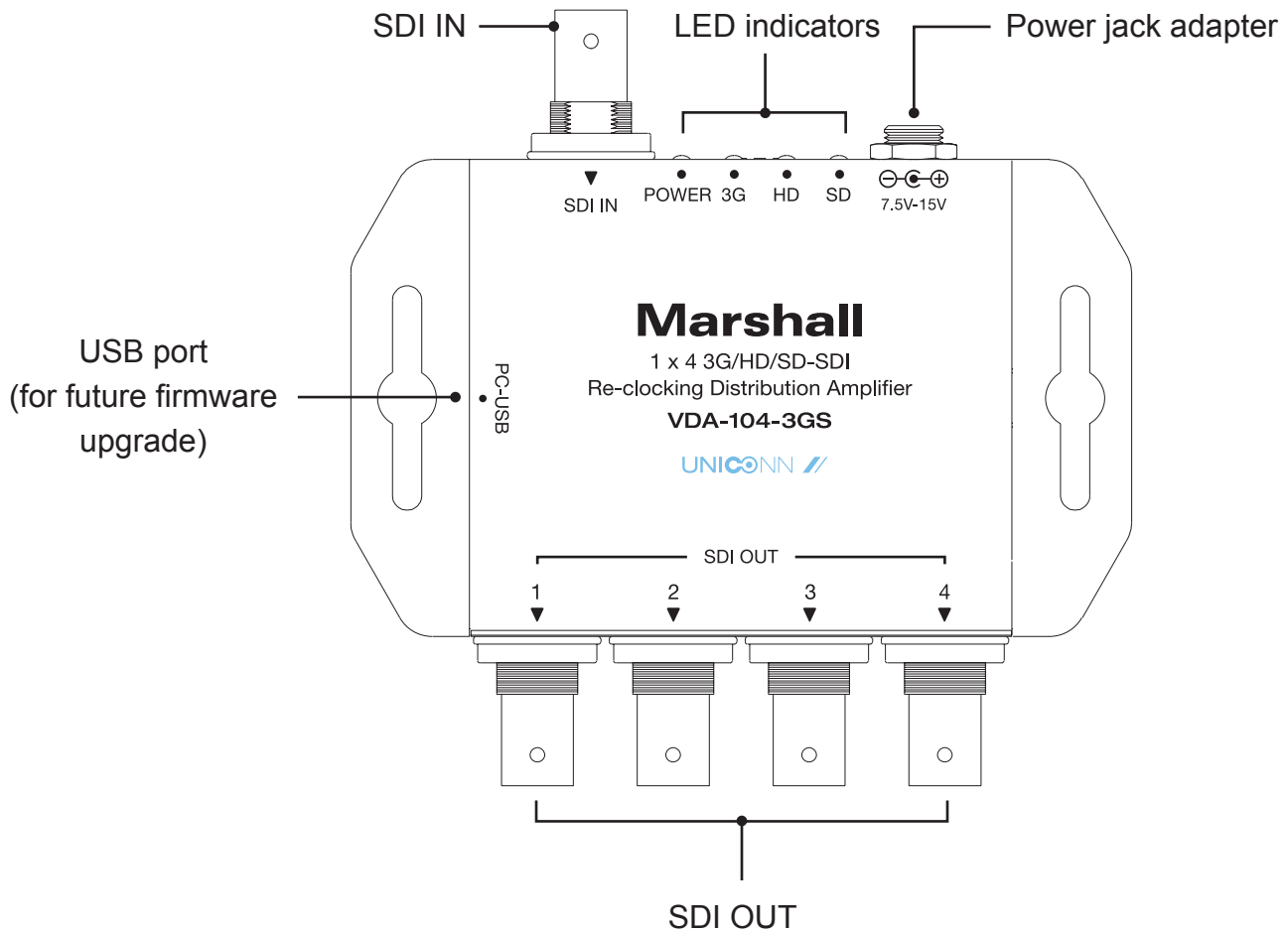

HARDWARE INSTALLATION

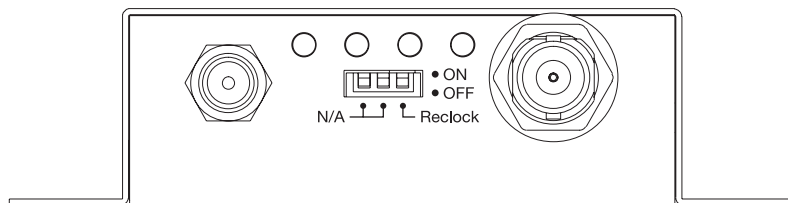
1. Connect source device (such as a camera) to the SDI IN connector.
2. Connect the destination devices (such as displays, recorders, switchers) to the SDI OUT connectors.
3. Connect the power adapter to the VDA-104-3GS.
4. Confirm that each destination device is receiving an input signal

DIP SWITCH



- **Reclock ON:** The VDA-104-3GS retransmits the incoming SDI signal after reclocking/reshaping and level boosting.
- **Reclock OFF:** The VDA-104-3GS retransmits the incoming SDI signal without reclocking or level boosting.
- **N/A:** These two switches have no function.
